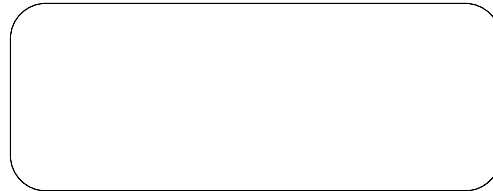
On a motion, second and voice note the meeting was adjourned at 8:34pm.
